#### **First Bonfire**


On Tuesday 30<sup>th</sup> January, LBS members turned out for their first event of 2024: First Bonfire at The Witch Inn.

The subsequently enacted Observance of 5 November Act fixed November the fifth as a date of celebration.

Anyway, enough of history! We are the only society to commemorate the first bonfire, and so as a result, many societies attend, for the opportunity to catch up with friends over a beer.

As usual our good friends from Skulldrummery attended and performed in the beer garden, before our Harbourmaster, David Riddle led the assembled in reciting the Bonfire Prayer.

In accordance with the company's articles of association, the company requires a minimum of 5 directors to hold office.
- A quorum for the Annual General Meeting is 7 members.
